Quality Improvement (QI)

This is one of the ways in which we can progress care together and develop our practice for tomorrow. This is not just for the benefit of the animals we treat, but for our teams' job satisfaction and for our clients too. Anyone within our practices can get involved and you can start making a difference by expressing an interest.

"Since learning of the benefits of post op coding and the very useful data this can generate for our teams, we began encouraging and supporting our practices to get involved. In the past six months many of our practices have started post op coding routinely. Initially we looked at coding neuter surgery wounds and more recently we are undertaking post op coding for all wounds. In many practices now, there is increased enthusiasm as our nurses and vets see the benefits of this project. We look forward to harnessing this data for QI and for pooling our outcomes and experiences to learn as a group."

Developing Resources to Support Clinical Decision Making

Throughout 2024 our clinical boards, together with our Clinical Interest Groups (CIGs) and study groups have created numerous evidence-based resources to support our teams in practice, review new medicines which have come on the market and address knowledge gaps that have been reported to us.

Examples of the resources developed this year include:

In 2024 we developed 202 clinical decision-making resources for our teams.



Senvelgo (velagliflozin): a novel oral diabetes medication for cats

This resource includes information on the clinical use of Senvelgo, how it compares to insulin and what patient monitoring is required (including advice from a recent safety update from regulators).

Fireworks first aid for dogs

This resource contains information on managing acute noise phobias in dogs over the fireworks period. It includes tips on managing the environment, pharmaceutical options for reducing anxiety, as well as links for desensitisation programs and behaviourist support.





Equine Foot Radiographs

A practical guide to equine foot radiographs, created by the Equine Orthopaedic Clinical Interest Group (CIG). This resource supports teams in creating diagnostic-quality images of the foot.

Non-steroidal Anti-inflammatory Drugs (NSAIDs) for Castration and Disbudding in Calves

Aimed at clinicians, this resource describes the benefits of NSAID use when disbudding and castrating calves.





Lambing resources

The Farm Animal Clinical Board have reviewed and curated a selection of resources to assist our teams during lambing time.

Clinical Quality Improvement

At VetPartners we are always looking at our current standards of care and finding ways to progress these for the benefit of the animals we treat, our clients and our teams. You can learn more about our Quality Improvement (QI) work here.

In 2024 we surveyed our teams in the UK to understand what QI activities they were engaging with in their practices, identify where more support was needed and enable them to share their great ideas. We collected a total of 126 useable responses representing 114 practices. The results showed that:









Clinical meetings are when clinical teams (colleagues who treat animals or talk to clients/customers) meet specifically to discuss clinical cases or processes, new medicines, CPD etc.






Clinical audit is the process of measuring how we are currently doing something so we can decide if it needs changing or not.





Checklists are useful for ensuring key steps in a process are not missed during a busy day and within a potentially distracting environment. A checklist should improve consistency and quality of care.





Significant event audits/meetings may be a separate practice meeting, or part of a clinical meeting when the team discusses something that didn't go to plan, or nearly went wrong that was potentially in their control or avoidable. It also includes talking about things that went really well so they can be repeated!



"The Vetpartners Equine IV catheter QI project is another fantastic example of what can be achieved through collaboration across our equine practices. 
Antibiotic Stewardship

Working alongside our teams, a key Quality Improvement (QI) measure for our group has been the absolute quantity of antibiotics we regularly prescribe and use. Using the data collected, a key objective of our work is to safely enable us to appropriately reduce and refine our antibiotic use without harming patient outcomes.

Over the last few years in the UK, we have developed a method of monitoring this antibiotic purchasing relative to the number of prescribers (full time equivalent vets - FTE[Vet]) in our organisation.

Across the VetPartners UK team between January 2024 and December 2024:

We have reduced our antibiotic purchasing (in kg per FTE[vet]) by 47% since 2021.



We bought **4,290kg of antibiotics** (compared to 5,588kg in 2023, 5,713kg in 2022 and 6,772kg in 2021)

On average we bought **2.34kg per full time equivalent vet across the year** (compared to 3.15kg/FTE[vet] in 2023, 3.48kg/FTE[vet] in 2022 and 4.39kg/FTE[vet] in 2021)

This means we have **reduced our antibiotic purchasing**(in kg per FTE[vet]) by 47% since 2021

This is testament to our amazing teams and their ongoing commitment to progressing practice and safeguarding antibiotic use.

Our clinical QI work on optimising surgical outcomes has continued across all species.

Utilising Post Op Coding for Quality Improvement Work

A post op code is a specific no cost code assigned to the patient within the Practice Management System (PMS) which describes the state of a surgical site following a procedure. We have audited our post op codes for routine neutering (speys and castrates) to look at outcomes for cat, dog and rabbit surgeries. This audit began in the UK in 2021 and extended to Europe in 2024. To date, we have collected data from over 27,000 coded surgeries.



Overall, our data have shown that more than 93% of neuter patients had no or only minor problems post-operatively in 2024, compared to 92.1% in 2021 when we started auditing. We have also seen increased engagement with post op coding among our teams in 2024, up 29% compared to when we started.

We have analysed over 27,000 routine surgeries and used these data to help people progress their analgesia protocols and demonstrate excellent levels of patient safety.

Equine Castration Audit

This ongoing audit has to-date gathered information on 658 castrations with follow up on 403 procedures so far, these data have shown that:

- We do the majority of castrates standing and in the horse's stable.
- The type and length of antibiotic use varies amongst clinicians
- We have a complication rate of ~19%



Cattle Caesar Audit

Our audit of cattle Caesars has continued throughout 2024. To date we have had data from 719 Caesars across 509 farms, with follow-up data received on 410 surgeries so far. Data have shown that:

- Feto-maternal disproportion is the biggest reason for a Caesar (63%; 242/386)
- Survival of the dam to 60 days is higher if she is standing (90%; 308/341) at surgery vs recumbent (71%; 32/45)
- The type of local anaesthetic block currently doesn't seem to effect success of wound healing







Clinical Research and Evidence-based Veterinary Medicine

Clinical research is a key part of how we continue to develop practice across the group. We are a hugely diverse group in our types and geographies of practices, and the species and problems we encounter. All of this provides a huge pool of collective information. Clinical research is a way of harnessing that to make sure we have the best information possible to keep making good decisions, whether it's about diagnosis, treatment, communication, or

Across our teams we have also published over 45 publications and articles.



anything else that's important to our teams. We are proud to be working with colleagues near and far on an array of different projects and have presented our research at a variety of different conferences. Examples of some of our practitioner-lead projects are shown below:



- Prevalence of endoparasites in dogs that are and aren't regularly dewormed (VP Research Award). Led by Nicole Dyer (Ash Tree).
- A systematic review of the diagnostic test accuracy of SDMA in the diagnosis of CKD in dogs. Led by Caroline Scobie (Westway).
- A ten-year comparative analysis of ocular bacterial flora and antimicrobial sensitivity in uninfected and infected eyes of dogs, cats and humans (2013-2023): A Scoping Review. Led by Susan Farr (Abbey Veterinary Group)



- Multicentre prospective study to evaluate the effect of the Prineo® closure system on the incidence of surgical site infections in exploratory celiotomies. Led by Andrew Wood (Liphook).
- Increased serum scores of the cyathostomin blood test associate positively with clinical larval cyathostomiasis (BEVA abstract). Led by Tashina Roy Choudhury (Three Counties).



Development of rapid antimicrobial susceptibility testing (RAST) for poultry (VP Research Award). Led by Cosmin Chintoan-Uta (PHS).



 Prevalence of and risk factors for Udder Cleft Dermatitis in dairy cows (VP research award and BCVA abstract). Led by Will Gratwick and Natalie Parker (LLM).

Clinical Research



PROJECTFEET /

Project FEET explores how the whole mobility team (farmers, foot trimmers, veterinary surgeons and veterinary technicians) perceive the pain associated with various lameness-causing conditions and make choices about managing these conditions, including when and whether to use NSAIDs.



We have published our first paper for this study and currently have a second paper in draft ready to submit for publication.

PROJECT DRAPES

'Drapes in Routine Aseptic Procedures for Environmental Sustainability'.

Project DRAPES is our first randomised controlled trial across VetPartners practices, which started in 2022, aims to see whether using disposable drapes in routine surgeries gives different patient outcomes compared with using washable, reusable drapes, which have less lifetime environmental impact.



This project has been making fantastic progress with the 1000th surgery submitted at the end of 2024! The full study protocol can be accessed here.

PROJECTWORMS >

'Working to Overcome Resistance and Make for a Sustainable future'.

Project WORMS recognises that veterinary teams and owners need to work together to tackle resistance to worming products. A responsible approach to the use of wormers is crucial to maximise animal welfare and ensure we have effective products available in the future.

We have published **part one** and **part two** of the owner-focused component of this study, submitting four papers for publication overall. We will continue to move this project forwards with our partners.



"It's exciting to see the first stage of Project Worms published in such a respected journal. This project is both timely and crucial in addressing anthelmintic resistance in equines. It's been a true collaborative effort, with CVS, IVC, and BEVA joining forces with VetPartners' Clinical Board members on a research initiative for the first time. This collaboration highlights the importance of this critical issue to the equine industry. The surveys conducted are the largest of their kind in the UK, offering a valuable snapshot of equine keepers' behaviours and decisions around management practices, testing, and the preventative treatment of intestinal parasites in horses. This information is crucial for driving, as well as monitoring, the significant behavioural changes needed in how decisions are made about anthelmintic use in horses. The data also provide a valuable baseline, prior to recent industry initiatives, such as CANTER and BEVA ProtectMeToo".

PROJECT NURSE

'Nurturing and Utilising R(E)VN Skills and Experience'.

Project NURSE aims to improve animal health and welfare by addressing the strong interest among our equine nursing teams in developing their clinical roles and providing more client-facing services.
